

## **Direct Payment Plan**

## Dear Customer

Sign up for our Direct Payment Plan and your monthly water bill payment will be deducted electronically from your checking or savings account. There is no charge for this payment option.

- Complete the Application for Direct Payment Plan
- > Attach a check from your bank account marked VOID or a printed deposit slip
- > Return the completed application and the VOID check / deposit slip to our office
- Continue paying your water bill in the manner you have done in the past UNTIL you receive your first water bill with the wording, DRAFT, printed on the bill. Once you receive this bill, your Direct Payment Plan will be in effect.
- > Your bank account will be drafted each month three days prior to the bill due date
- > To discontinue payment by the Direct Payment Plan, you must notify the District in writing thirty days in advance of the cancellation date

## **Insufficient Funds Policy**

In the event that the customer's bank does not accept our electronic draft request, the customer will be mailed a letter immediately at the billing address stating: Amount of the bill and a service charge must be paid immediately by cash or money order at the District's office and no later than five days from the date of the letter by 12:00 p.m. (noon). If payment is not received by the date and time specified, water service will be terminated in accordance with the District's policy for termination of service. All fees for termination and reconnection of water service will also be charged and must be paid by cash or money order prior to turning on the water.
